WHEREAS, funding has been made available to the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) for the following programs:

1. Execution of Agreement with Cuyahoga County Board of Developmental Disabilities (CCBDD) and Warrensville Developmental Center **in the amount of \$40,000.00**; and,
2. ODMH Notice of Sub-Award (NOSA): Early Learning Challenge Grant – Positive Education Program **in the amount of \$99,780.00**; and,
3. Mental Health Program at Community Based Correctional Facility (CBCF) – Recovery Resources **in the amount of \$69,750.00**; and,
4. Psychiatric Services for the Cuyahoga County Community Based Correctional Facility – Cuyahoga County Court of Common Pleas **in the amount of \$79,000.00**; and,

WHEREAS, the ADAMHS Board of Directors Finance and Operations Committee has reviewed the ADAMHS Board staff's recommendation and recommends that the Board of Directors accept the funding and authorize the ADAMHS Board to pay the required local matches and enter into any necessary interagency agreements.

- A. The ADAMHS Board of Directors accepts the funds and authorizes payment of any required local match for the following:
 1. Execution of Agreement with Cuyahoga County Board of Developmental Disabilities (CCBDD) and Warrensville Developmental Center **in the amount of \$40,000.00**; and,
 2. ODMH Notice of Sub-Award (NOSA): Early Learning Challenge Grant – Positive Education Program **in the amount of \$99,780.00**; and,
 3. Mental Health Program at Community Based Correctional Facility (CBCF) – Recovery Resources **in the amount of \$69,750.00**; and,
 4. Psychiatric Services for the Cuyahoga County Community Based Correctional Facility – Cuyahoga County Court of Common Pleas **in the amount of \$79,000.00**; and,
- B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary interagency agreements
