- 5. Amendment to Resolution 12-11-04 to increase the match requirement in the agreement with the Ohio Rehabilitation Services Commission for the period October 1, 2012 through September 30, 2013. The increase in match funding was \$176,620.38 (from \$693,505.11 to \$870,125.48).
