 - Jewish Family Services Association for the period October 1, 2013 through September 30, 2014 **in the amount of \$337,214.63**
 - Recovery Resources for the period October 1, 2013 through September 30, 2014 **in the amount of \$628,367.21**
 - Pooled funding for case service supportive funds for the period October 1, 2013 through September 30, 2014 **in the amount of \$2,250,000.00;**

- Recovery Resources for the period October 1, 2013 through September 30, 2014 **in the amount of \$628,367.21**
- Pooled funding for case service supportive funds for the period October 1, 2013 through September 30, 2014 **in the amount of \$2,250,000.00; and,**
