WHEREAS, the ADAMHS Board staff recommends the dissolution of the Faith-based Outreach Subcommittee; and,

WHEREAS, the ADAMHS Board Executive Committee has reviewed the ADAMHS Board staff's recommendation and recommends that the Board of Directors approve the dissolution of the Faith-based Outreach Subcommittee.
