WHEREAS, William M. Denihan, CEO, and Executive Staff began the process of developing recommended priorities for CY 2016 in compliance with the Board's policy on the Prioritization of Services and Resources; and,

WHEREAS, this policy is implemented during the planning and funding process and may utilize various resources, such as needs assessments, surveys, polling, focus groups, stakeholders and the Ohio Department of Mental Health and Addiction Services practices; and,

WHEREAS, the ADAMHS Board is in the process of establishing a Recovery Oriented System of Care (ROSC) in Cuyahoga County and the CEO and Executive Staff have considered the results from the Self-Assessment issued in July 2015; and,

WHEREAS, the preliminary results of this Self-Assessment were presented to the Board of Directors Community Relations & Advocacy and Planning & Oversight Committees during the September meeting cycle; and,

WHEREAS, with the ROSC in mind, the CEO and Executive Staff recommend that the 2016 priorities be established in two categories: 1) System and 2) Mental Health & Addiction Services: Adult and Children/Adolescents; and,

WHEREAS, the recommended CY2016 priorities are not ranked in order of importance as all are considered equally important; and,

WHEREAS, the CEO recommends the following CY2016 Priorities be adopted by the full Board:

- Recovery Oriented System of Care:
 - Interim services for people on waiting lists and/or who are not ready to commit to treatment. i.e., Seasons of Hope, outreach, hotline number promotion, NAMI programs, etc.
 - Integrated primary and behavioral healthcare.
 - Increase opportunities for client employment.
 - Age appropriate peer support.

- Dedicated Levy
- State Funding Advocacy
- SHARES Go Live
- System Coordination Enhancement
- Training
- Capital Operations
- Capacity Study
- Needs Assessment
- Evidenced-Based Practices
