 - FrontLine Services
2. OhioMHAS – Amendment to Resolution 15-07-04 Pass Through Funding for Substance Abuse Prevention and Treatment (SAPT) – Treatment Alternatives to Street Crime Programs (TASC) **for the period July 1, 2015 through June 30, 2016 in the additional amount of \$42,900.00**
 - Catholic Charities Corporation
 - Cuyahoga County Court of Common Pleas;
3. Cuyahoga County Corrections Planning Board – Drug Court Sustainability **for the period January 1, 2016 through December 31, 2016 in the amount of \$100,000.00**
 - Community Assessment and Treatment Services

WHEREAS, the ADAMHS Board Finance and Operations Committee has reviewed the ADAMHS Board staff's recommendation and recommends that the Board of Directors accept the funding and authorize the ADAMHS Board to pay the required local matches and enter into any necessary interagency agreements.

 2. Cuyahoga OhioMHAS – Amendment to Resolution 15-07-04 Pass Through Funding for Substance Abuse Prevention and Treatment (SAPT) – Treatment Alternatives to Street Crime Programs (TASC) **for the period July 1, 2015 through June 30, 2016 in the additional amount of \$42,900.00**
 - Catholic Charities Corporation
 - Cuyahoga County Court of Common Pleas;

3. Cuyahoga County Corrections Planning Board – Drug Court Sustainability **for the period January 1, 2016 through December 31, 2016 in the amount of \$100,000.00**

- Community Assessment and Treatment Services.
