# CEO Succession Planning Timeline - REVISED As of January 25, 2017

## **April 2015**

 The ADAMHS Board of Directors approved a Management Plan for Executive Leadership in the absence of the Chief Executive Officer.

## **April 2015 – May 2015**

- The ADAMHS Board used the services of Ed Towns, of Business Advisers of Cleveland, to compare salaries and benefits of other Chief Executive Officer positions.
- Mr. Towns prepared a pay analysis for the Chief Executive Office position and proposed a salary range for the position.

## **July 2015**

 The ADAMHS Board entered into a contract with BVU: The Center for Nonprofit Excellence to assist Chief Denihan in preparing a succession plan for the Chief Executive Officer position.

## September 2015 – February 2016

- BVU: The Center for Nonprofit Excellence worked with the Chief Executive Officer in developing a succession plan.
- BVU presented Chief Denihan's succession plan and provided training to the ADAMHS Board of Directors on the process of Succession Planning.

## **May 2016**

• The ADAMHS Board Chair appointed several Board Subcommittees, including the CEO Evaluation Subcommittee and the Succession Planning Subcommittee.

## **August 2016 – December 2016**

Ongoing conversations continued with BVU regarding CEO Search Preparation.

#### December 2016

Review proposal submitted from BVU for CEO Search Preparation.

## January 2017

- BVU meet with the Succession Planning Subcommittee to discuss the process.
  - o (January 9, 2017 at 3pm)
- Succession Plan Subcommittee report out and recommend BVU contract to be approved through Board meeting cycle.
  - o (Finance Committee 1/18/17 & General Mtg. 1/25/17)
- ADAMHS Board's Executive Committee begins CEO Search process.
  - o (General Meeting on 1/25/17)

## February & March 2017

- BVU meets with Executive Committee to review the job description.
- BVU meets with Executive Committee to develop behavioral based interview questions and train the committee.
- CEO position will be advertised internally and externally.
- Board's Executive Committee will interview applicants.

## **April 2017**

- Executive Committee will recommend a candidate to the full Board.
- ADAMHS Board of Directors will vote to approve/disapprove the recommended candidate.

## April/May 2017

Announcement of new ADAMHS Board Chief Executive Officer.

## **June & July 2017**

Transition period.

#### August 1, 2017

- Chief Denihan retires.
- New CEO officially assumes duties.
