**APPROVAL OF ADAMHS BOARD OF CUYAHOGA COUNTY  
2017-2020 STRATEGIC PLAN**

**WHEREAS**, the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) has engaged in the strategic planning process and has worked with key stakeholders, comprised of representatives from ADAMHS Board of Directors, management, staff, provider representatives, clients, and community members, who provided information, discussion, and recommendations during a series of strategic planning groups; and,

**WHEREAS**, the ADAMHS Board 2017 – 2020 Strategic Plan has been completed and provides a clearer definition of what the community expects of the ADAMHS Board and what the ADAMHS Board expects of itself. The process also served to identify and address gaps in service, acknowledge key challenges and issues, create solutions, and embrace a collective vision for the future; and,

**WHEREAS**, the ADAMHS Board three-year Strategic Plan is intended to be a *living document* that will change with the ever-changing environment. There are five overall strategic goals that will guide the Board's objectives and action steps:

1. Our programs and services will enhance and maintain a culturally competent, comprehensive, and fully integrated system of behavioral healthcare that is cost effective and outcomes driven toward resiliency and recovery.
2. Our programs and services will deliver quality results through consistent and standardized data collection, monitoring and outcomes measurement practices.
3. Our programs, services, and mission will be supported by increased and consistent public and private funding.
4. Our Board will promote and encourage consistent and compelling advocacy and community engagement efforts that educate, inspire, and result in action.
5. Our Board will be properly aligned with adequate internal capacity to meet the goals of a Recovery Oriented System of Care and a fully integrated Behavioral Healthcare System.

Periodic updates will be provided to the ADAMHS Board of Directors on the goals achieved and progress made on the plan; and,

**WHEREAS**, the ADAMHS Board Executive Committee has reviewed the 2017 – 2020 Strategic Plan and recommends that the full ADAMHS Board of Directors adopt the three-year Strategic Plan, which is intended to be a *living document* that will change when necessary with the changing environment.

**NOW, THEREFORE, BE IT RESOLVED:**

1. The ADAMHS Board of Directors adopts the ADAMHS Board three-year Strategic Plan that is intended to be a living document that will change when necessary with the changing environment.

2. The ADAMHS Board Chief Executive Officer is hereby authorized to make the necessary edits to the ADAMHS Board Strategic Plan 2017 – 2020, and execute the provisions thereof.
