**WHEREAS**, the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) Chief Executive Officer (CEO) has determined it necessary and within the operational budget to enter into operational and administrative contracts/agreements with the following entities:

3. Sponsorship: **FrontLine Service**– Beyond the Storm – The Art of Healing on **June 2<sup>nd</sup>, 2017** in the amount of **\$1,000.00**;
4. Sponsorship: **Alive on Purpose** – Alive on Purpose Father and Daughter Gala on **August 6<sup>th</sup>, 2017** in the amount of **\$1,000.00**;
5. Summer Camp Prevention Program – **Hitchcock Center for Women** for the period **June 1, 2017 through August 31, 2017** in the amount of **\$22,000.00**; and;
