APPROVAL OF AMENDMENT TO RESOLUTION NO. 16-11-06 CALENDAR YEAR 2017 OPERATIONAL BUDGET

WHEREAS, the ADAMHS Board staff recommends that the CY 2017 ADAMHS Board Operational Budget approved in Resolution No. 16-11-06 be increased from \$73,095,183.00 to \$78,271,672.00, an increase of \$5,176,489.00; and,

- b. <u>CY2017: Medicaid Budget \$4,400,000.00 (\$600,000.00 Increase From Current Budget of \$3,800,000.00)</u>
- c. <u>CY2017: Provider Direct Services Budget \$59,201,504.00 (\$149,861.00 Increase</u> From Current Budget Amount of \$59,051,643.00)
- d. CY2017: Other Behavioral Health Services Budget \$4,818,000.00 (\$1,400,000.00 Increase from Current Budget Amount of \$3,418,000.00)
- e. <u>CY2017: Opportunities for Ohioans With Disabilities (OOD) FFY17 Case Service Contract \$1,125,540.00 (No Change From Current Budget)</u>
- f. <u>CY2017: Federal Grants \$3,026,628.00 (\$3,026,628.00 Increase from Current Budget)</u>

WHEREAS, the ADAMHS Joint Planning and Finance Committee has reviewed the proposed increased CY 2017 ADAMHS Board Operational Budget and recommends that the Board of Directors adopt said amendment.
