## **RESOLUTION NO. 18-03-03**

## AUTHORIZATION TO ISSUE A REQUEST FOR PROPOSAL IN PARTNERSHIP WITH THE CUYAHOGA COUNTY DIVISION OF CHILDREN & FAMILY SERVICES FOR A TREATMENT FOSTER CARE/KINSHIP PILOT

**WHEREAS**, the Cuyahoga County Division of Children and Family Services (CCDCFS) staff has requested the ADAMHS Board's assistance in developing a clinical model to support children and their families in foster care and relative/kinship placements; and,

**WHEREAS**, the CCDCFS has identified a critical need within their system to expand its current foster care programming to include treatment foster homes, as well as the provision of timely individualized behavioral health interventions with children/youth stepping down from a residential placement or placed with a relative/kinship caregiver; and,

**WHEREAS**, as the number of relative/kinship placements have increased, families are in need of a multitude of services and supports to maintain these youth in their homes; and,

**WHEREAS,** CCDCFS has identified the *Trust Based Relational Intervention*® (*TBRI*®), an evidenced based intervention, to be utilized concurrently with behavioral health services and support for children who have experienced relationship-based traumas; and,

**WHEREAS**, the Board is interested in helping to assist in developing a model to "pilot" the intensive level of support in tandem with a dedicated behavioral health agency to be identified through a vetting process; and,

**WHEREAS**, the clinical services to be included are the following: Assessment & Screening, Therapeutic Interventions, Psychiatric Assessments and Pharmacological Services, Case Management and Care Coordination for behavioral health support and Crisis Intervention; and,

WHEREAS, the following timeline is recommended for the issuance of the RFP for this program:

- 1. March 14<sup>th</sup>, 2018: request permission from the ADAMHS Board of Directors Planning & Operations Committee; and,
- 2. March 28th, 2018: seek final approval from the ADAMHS Board of Directors; and,
- 3. First week of April 2018: release the Treatment Foster Care/Kinship Pilot RFP; and,
- 4. May 4th, 2018: proposal submission deadline; and,
- 5. May 18th, 2018: upon approval of membership from the ADAMHS Board Chief Executive Officer, the Review Committee will render a recommendation for approval to process through the June 2018 ADAMHS Board of Directors meeting cycle, with a goal to initiate a contract in July 2018; and,

**WHEREAS**, the ADAMHS Board's Planning & Oversight Committee reviewed Board staff's recommendation and recommends authorizing the issuance of a Request for Proposal for the Cuyahoga County Treatment Foster Care Initiative/Kinship Pilot.

## NOW, THEREFORE, BE IT RESOLVED:

- 1. The ADAMHS Board of Directors approves the issuance of a Request for Proposal to partner with CCDCFS to develop and release a RFP for the provision of clinical and supportive services for treatment foster care and relative/kinship homes as a pilot.
- The ADAMHS Board CEO is hereby authorized to appoint a RFP Committee to review and evaluate the RFP proposals received, and to submit its recommendation to the Board of Directors.
