- 3. State of Ohio CCA-407 Funding from Cuyahoga County Common Pleas Court/Corrections Planning Board (CCPB) for Residential Services for Men who are Dually Diagnosed Catholic Charities/Matt Talbot in the amount of \$160,000.00.
- Cuyahoga County Common Pleas Court/Corrections Planning Board (CCPB) for Residential Treatment Services for Offenders Supervised by the Adult Probation Department – Catholic Charities/Matt Talbot, Community Assessment & Treatment Services (CATS) and ORCA House in the amount of \$500,000.00.

- 3. State of Ohio CCA-407 Funding from Cuyahoga County Common Pleas Court/Corrections Planning Board (CCPB) for Residential Services for Men who are Dually Diagnosed Catholic Charities/Matt Talbot in the amount of \$160,000.00.
- 4. Cuyahoga County Common Pleas Court/Corrections Planning Board (CCPB) for Residential Treatment Services for Offenders Supervised by the Adult Probation Department Catholic Charities/Matt Talbot, Community Assessment & Treatment Services (CATS) and ORCA House in the amount of \$500,000.00.
