## **RESOLUTION NO. 18-06-01**

## AUTHORIZATION TO ISSUE A REQUEST FOR PROPOSAL FOR BEHAVIORAL HEALTH SERVICES IN THE CUYAHOGA COUNTY JUVENILE COURT INTERVENTION CENTER

**WHEREAS**, the Cuyahoga County Juvenile Court has requested ADAMHS Board's participation in the planning process for an Intervention Center which will serve all pre-adjudicated youth, with the goal being to limit or prevent deeper penetration into the juvenile justice system; and,

**WHEREAS**, the Cuyahoga County Juvenile Court (CCJC) has identified a critical need for earlier identification and diversion of youth with behavioral health needs into clinically appropriate services and supports; and,

**WHEREAS**, the ADAMHS Board has agreed to assist in developing clinical components of the Intervention Center and to identify a dedicated behavioral health agency to deliver the proposed services through a vetting process; and,

**WHEREAS,** the behavioral health services to be included are: Assessment & Brief Behavioral Health Screening, Case Management, Referral to Respite Services for Crisis Intervention, and Navigation & Linkage to appropriate services and supports; and,

**WHEREAS**, the following timeline is recommended for the issuance of the RFP for this program:

- 1. <u>June 13, 2018:</u> request permission to release the RFP from the ADAMHS Board of Directors Planning & Oversight Committee
- 2. <u>June 27, 2018:</u> seek final approval to release the RFP from the ADAMHS Board of Directors
- 3. <u>First week of July 2018:</u> release the *Behavioral Health Services in the CCJC Intervention Center RFP*
- 4. August 3, 2018: proposal submission deadline
- August 17,2018: upon approval of membership from the ADAMHS Board CEO, the Review Committee will render a recommendation for approval to process through the September 2018 ADAMHS Board of Directors meeting cycle, with a goal to initiate a contract in January 2019

**WHEREAS**, the ADAMHS Board's Planning & Oversight Committee reviewed Board staff's recommendation and recommends authorizing the issuance of a Request for Proposal for Behavioral Health Services in the Cuyahoga County Juvenile Court Intervention Center.

## NOW, THEREFORE, BE IT RESOLVED:

- 1. The ADAMHS Board of Directors approves the issuance of a Request for Proposal for Behavioral Health Services in the Cuyahoga County Juvenile Court Intervention Center.
- The ADAMHS Board CEO is hereby authorized to appoint a RFP Committee to review and evaluate the RFP proposals received, and to submit its recommendation to the Board of Directors.
