AUTHORIZATION TO ISSUE A REQUEST FOR PROPOSAL FOR EARLY CHILDHOOD MENTAL HEALTH SERVICES

WHEREAS, the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) has a Contractual Agreement with the Cuyahoga County Office of Early Childhood-Invest in Children (IIC), to issue a Request for Proposal (RFP) every two years to procure contracts for the unique specialization of early childhood consultation, early intervention and treatment services; and,

WHEREAS, the Cuyahoga County Office of Early Childhood-Invest in Children (IIC) provides funding to the ADAMHS Board for Early Childhood Mental Health Services (ECMH); this funding is used to provide early intervention services which ensure that our community's children are prepared for a successful start academically and socially; and,

WHEREAS, ECMH services benefit children ages birth through six by enhancing social-emotional development through the provision of services delivered with a keen awareness of the significance of early brain development and the adverse effects of trauma, abuse, neglect and other negative experiences that impact healthy emotional development; and,

WHEREAS, the timeline for issuance of the RFP is as follows:

- June 13th, 2018: request permission from the ADAMHS Board of Directors Planning & Oversight Committee
- 2. <u>June 20th, 2018:</u> request permission from the ADAMHS Board of Directors Finance & Operations Committee
- 3. June 27th, 2018: seek final approval from the ADAMHS Board of Directors
- 4. First week of July 2018: release the Early Childhood Mental Health Services RFP
- 5. August 13th, 2018: proposal submission deadline
- 6. August 30th, 2018: upon approval of membership from the ADAMHS Board CEO, the Review Committee will render a recommendation for approval to process through the September, 2018 ADAMHS Board of Directors meeting cycle, with a goal to initiate a contract in January 2019.

WHEREAS, the ADAMHS Board Planning & Oversight Committee reviewed the ADAMHS Board staff's recommendation and recommends authorization to issue a Request for Proposal for Early Childhood Mental Health Services.

NOW, THEREFORE, BE IT RESOLVED:

- 1. The ADAMHS Board of Directors approves the issuance of a RFP to solicit applications for the provision of services for Early Childhood Mental Health Services from January 01, 2019 through December 31, 2020.
- 2. The ADAMHS Board CEO is hereby authorized to appoint the RFP Committee to review and evaluate the RFP proposals and to submit its recommendation to the Board of Directors.
