4. Northeast Ohio Regional Collaborative: Withdrawal Management-Detoxification and Mental Health Crisis Expansion (\$2,400,000.00) for the period **July 1, 2017 through June 30, 2019** in the amounts of:

 - c. Positive Education Program - \$117,423.00; and,
