APPROVAL OF CALENDAR YEAR 2019 CONTRACTS FOR FAITH-BASED OUTREACH INITIATIVES

WHEREAS, the ADAMHS Board's Faith-Based Outreach Initiative program will promote spirituality, health and wellness, prevention/early intervention, awareness and education, reduce/eliminate stigma within communities impacted by mental health and substance use and build and increase resiliency to achieve positive change; and,

WHEREAS, on October 17, 2018, the Committee of the Whole approved the issuance of a Request for Proposal (RFP) for programs/events/activities that address growing challenges our behavioral health/substance abuse clients and the faith community face; and,

WHEREAS, the ADAMHS Board staff received and reviewed twenty-two responses to the RFP and is recommending nine organizations to participate in the CY2019 Faith-based Outreach Initiatives program; and,

WHEREAS, funding will be utilized to provide education, training, and after-school/weekend activities that promote awareness regarding the harmful effects of substance use and other mental health risk factors; and,

WHEREAS, the initiatives will increase social supports and protective factors within the faith-based community to recognize the harmful effects of substance use and other mental health symptoms that are untreated; build and increase resiliency to achieve positive change in community; decrease risk-factors for children and adolescent and increase social-emotional competencies; and,

WHEREAS, ADAMHS Board staff recommend entering into Calendar Year 2019 Contracts for Faith-Based Outreach Initiative agreements with the following organizations and recommended amounts:
