**APPROVAL OF AGREEMENT WITH CUYAHOGA COUNTY BOARD OF
DEVELOPMENTAL DISABILITIES (CCBDD) FOR SHARED FUNDING**

WHEREAS, the Shared Cost Agreement between the ADAMHS Board and Cuyahoga County Board of Developmental Disabilities (CCBDD) is to allow CCBDD to share the cost of residential placements for youth identified through Family and Children First Council's (FCFC) Service Coordination Team; and,

WHEREAS, the youth in question are at high risk to themselves and others and require a residential treatment facility to provide behavioral health treatment services for which CCBDD does not contract; and,

WHEREAS, the Shared Cost Agreement not only affords CCBDD to share the cost of residential treatment services, but also to share in funding the Crisis Stabilization Bed for youth with co-occurring disorders (developmental disability and a mental health diagnosis); and,

WHEREAS, a previous agreement was updated in 2017 to include the crisis stabilization bed as one-time funds allocated to the ADAMHS Board through the state expired in 2015; this additional crisis stabilization bed filled a necessary gap within the children's system for which CCBDD agreed to fund 50% of the contracted amount; and,

WHEREAS, the CCBDD shall reimburse the ADAMHS Board fifty percent (50%) of the actual cost incurred by the ADAMHS Board for each placement; such reimbursement shall be considered the CCBDD's share of the client's cost of residential services; and,

WHEREAS, the ADAMHS Board Planning & Oversight Committee reviewed and recommends entering into a Shared Funding Agreement with the CCBDD for the time period beginning June 1, 2019 and ending May 31, 2021.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The ADAMHS Board of Directors approve entering into an Agreement with the Cuyahoga County Board of Developmental Disabilities for Shared Funding for the time period of June 1, 2019 through May 31, 2021.
2. The ADAMHS Board Chief Executive Officer is hereby authorized to execute said Agreement and to make payments pursuant to its terms, subject to the availability of funds.
