  - a. FrontLine Service; and,
3. Franklin Manor, 1466 West 81<sup>st</sup> Street, Cleveland, Ohio – Building Repairs for the time period February 27, 2020 through December 31, 2020 in the amount not to exceed \$95,163.00 for the following contract:
  - a. EDEN, Inc.; and,
4. Friendly Inn Settlement, Inc. Behavioral Health Center for the time period March 1, 2020 through December 31, 2020 in the amount of \$250,000.00 for the following contract:
  - a. Friendly Inn Settlement, Inc.; and,
5. Cuyahoga County Board of Health, Pass Through Funds from the Centers for Disease Control and Prevention through the National Network of Public Health Institute for the Adverse Childhood Experience (ACEs) Grant for the period January 1, 2020 through August 31, 2020 in the amount of \$5,000.00; and,
6. Northeast Ohio Collaborative: Withdrawal Management/Detoxification and Crisis Bed Expansion in the amount of \$975,000.00 for the following contracts:
  - a. Windsor Laurelwood for the period November 1, 2019 to June 30, 2020 - \$269,760.00
  - b. Stella Maris for the period January 1, 2020 to June 30, 2020 - \$147,143.00
  - c. Lake County ADAMHS Board for the period January 1, 2020 to June 30, 2020 - \$130,000.00
  - d. Applewood Centers for the period January 1, 2020 to June 30, 2020 - \$125,000.00
  - e. Ashtabula County Medical Center for the period January 1, 2020 to June 30, 2020 - \$125,000.00
  - f. Silver Maple Recovery Center for the period January 1, 2020 to June 30, 2020 - \$178,097.00; and,

**WHEREAS**, the ADAMHS Board Planning & Oversight Committee and the Finance & Operations Committee have reviewed the ADAMHS Board staff's recommendations and recommends that the Board of Directors accept the funding and authorize the ADAMHS Board to pay the required local match and enter into any necessary contractual agreements.

**NOW, THEREFORE, BE IT RESOLVED:**

A. The ADAMHS Board of Directors accepts the funds and authorizes payment of any required local match for the following:

1. Residential Assistance Program ( RAP) Reopening/Mini-Grants for Property Updates for the time period March 1, 2020 through December 31, 2020 in the amount of \$400,000.00 in the following allocation:
  - a. RAP Reopening - \$200,000.00
  - b. Mini-Grants for Property Updates - \$200,000.00; and,
2. FrontLine Service Mobile Crisis Team Staff Expansion for the time period March 1, 2020 through December 31, 2020 in the amount of \$600,000.00 for the following contract:
  - a. FrontLine Service; and,
3. Franklin Manor, 1466 West 81<sup>st</sup> Street, Cleveland, Ohio – Building Repairs for the time period February 27, 2020 through December 31, 2020 in the amount not to exceed \$95,163.00 for the following contract:
  - a. EDEN, Inc.; and,
4. Friendly Inn Settlement, Inc. Behavioral Health Center for the time period March 1, 2020 through December 31, 2020 in the amount of \$250,000.00 for the following contract:
  - a. Friendly Inn Settlement, Inc.; and,
5. Cuyahoga County Board of Health, Pass Through Funds from the Centers for Disease Control and Prevention through the National Network of Public Health Institute for the Adverse Childhood Experience (ACEs) Grant for the period January 1, 2020 through August 31, 2020 in the amount of \$5,000.00; and,
6. Northeast Ohio Collaborative: Withdrawal Management/Detoxification and Crisis Bed Expansion in the amount of \$975,000.00 for the following contracts:
  - a. Windsor Laurelwood for the period November 1, 2019 to June 30, 2020 - \$269,760.00
  - b. Stella Maris for the period January 1, 2020 to June 30, 2020 - \$147,143.00
  - c. Lake County ADAMHS Board for the period January 1, 2020 to June 30, 2020 - \$130,000.00
  - d. Applewood Centers for the period January 1, 2020 to June 30, 2020 - \$125,000.00
  - e. Ashtabula County Medical Center for the period January 1, 2020 to June 30, 2020 - \$125,000.00
  - f. Silver Maple Recovery Center for the period January 1, 2020 to June 30, 2020 - \$178,097.00

B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary contractual agreements.
