4. 2020 Census Outreach Campaign for the time period June 25, 2020 through August 31, 2020 in the amount of \$4,100 for the following contracts:
  - a. Call and Post - \$1,000
  - b. Entercom - \$2,000
  - c. The Mosound Group, Inc. - \$1,100; and,
