1. CALL TO ORDER / AUDIENCE INPUT

Board Chair, Benjamin Gohlstin, called the General Meeting to order at 4:00 p.m. No audience input received.

2. APPROVAL OF MINUTES - The minutes from the January General Meeting, held on 2/06/19, were approved as submitted.

3. RECOGNITION OF CLIENT ARTWORK DISPLAY - NOVEMBER 2018

Beth Zietlow-DeJesus, Director of External Affairs, highlighted the artwork produced by Safiyyah Muhammad who shared that creating artwork helps to alleviate stress, helps economically, and is something she wishes to pass down to her family. A certificate of participation was awarded for her impressive artwork.

5. FAITH-BASED OUTREACH COMMITTEE REPORT

On behalf of Committee Chair, Rev. Rodas, Starlette Sizemore-Rice, Director of Special Projects, gave an overview of the topics discussed at the February 6th Faith-based Outreach Committee meeting.

- Culturally competent materials: Faith-based materials are now available in Spanish.

6. PLANNING & OVERSIGHT COMMITTEE REPORT

Katie Kern-Pilch, P&O Committee Vice Chair, reported on the P&O Committee meeting held on 2/13/19. Committee members heard brief presentations:

- Music Therapy for Detox and Recovery Program was introduced by Ronna Kaplan, Chair of the Center for Music Therapy/The Music Settlement. Dr. Step suggested that this program be considered a "pilot" project and suggested that the Committee receive a review update after 90 days.
- Identification Crisis Collaborative (IDCC) presentation was given by Eileen Kelly, IDCC Executive Director, who explained the program's mission to assist individuals to obtain state ID's, birth certificates, etc. to help them obtain access to employment, medical testing, housing, education opportunities, etc.
- Jail Liaison Program Recommendations to revamp the program were shared by Board staff, Maggie Tolbert, Assistant Chief Clinical Officer, and Lindsey McMillion, Adult Behavioral Health Criminal Justice Specialist. It was noted that the Court and Board will split the cost of the Jail Liaison Specialist position.

- CURES Year 01 Carryover Funding Opportunity – Available funds are recommended to purchase and distribute Naloxone kits to MetroHealth Medical Center for distribution through the Cuyahoga County Sheriff's Office. Dr. Step requested the committee receive a monthly accounting of how many kits have been distributed.

- Recommended Agreements for Class 2 Residential Facilities that received the Peer Seal of Quality were discussed. The committee learned that 105 homes were inspected by peer specialists contracted by the ADAMHS Board. Of this number, 22 were recommended for a second onsite review that included Board staff; 15 homes were required to make additional corrections and/or repairs. Five homes were not recommended for a contract.
- Mr. Osiecki provided a comprehensive update for Goal 1 of the Strategic Plan; an update on Goal 2 will be shared at the March P&O Committee meeting.

8. RESOLUTION NO. 19-02-06 APPROVAL OF POSITIVE EDUCATION PROGRAM (PEP) APPEAL OF BOARD DECISION OUTCOME & OHIOMHAS MULTI-SYSTEM YOUTH (MSY) GRANT

Mr. Osiecki noted that the Positive Education Program appealed the ADAMHS Board's CY2019 funding decision regarding PEP's allocation. Per the ADAMHS Board's Appeal policy, the Board's CEO and staff met with PEP's CEO and staff on 2/21/19 to collaboratively mediate and/or negotiate a solution to the appeal.

As a result of an earlier notice to all ADAMHS Boards from OhioMHAS on 2/6/19 that a one-time allocation of \$3 million from the Mental Health Block Grant would be provided to Boards to support the needs of youth involved in multiple public systems, ADAMHS Board staff offered an allocation of \$200,000.00 from the Ohio Multi-System Youth (MSY) Grant to PEP Connections to help provide services for at-risk youth for the time period of 1/01/19 through 6/30/19.

PEP was in agreement with this solution and agreed to provide a detailed report to the ADAMHS Board by 7/15/19 on the amount and type of services provided, the number of youth served, and the youth average length of service paid for by the MSY grant. Also, the Board confirmed its willingness to partner with PEP to advocate for future funding for the program with County, OhioMHAS, Medicaid HMO's, etc. Once approved by the Board of Directors, the Board and PEP will enter into a Memorandum of Understanding (MOU) concerning the \$200,000.00 from the MSY grant.

9. CHIEF EXECUTIVE OFFICER'S REPORT

- Staff Update Ethics Training for Board staff is scheduled for 3/20/19 from 9:30-11:30 AM. Board members were invited to participate; 2 CEU's are available for this training.
- Northeast Ohio Collaborative The ADAMHS Board is acting as the fiscal agent for the NE Ohio Collaborative and we
 anticipate receiving those funds soon. The NE Collaborative is an effort to assists with out-of-county placements. Ms.
 Tolbert has been working with the gatekeepers for this collaborative to revamp the process.

Eaton Corporation Speaker's Bureau - Scott participated on a panel discussion about the opioid crisis at the Eaton Corporation's series, "Strive for Change" that was available to all of Eaton's 21 sites through a live video feed. Scott looks forward to participating on another Eaton panel regarding mental health in the future.

- Mental Health Addiction & Advocacy Coalition Scott met with Joan Englund, Executive Director, and Karen Kearney, Northeast Hub Director, to talk about entering into the County budget process for CY2020-2021. We shared with them that the Board made a funding request of Council President Dan Brady several months ago and that the same amount would probably be requested going forward. Ms. Osiecki and Ms. Harrison have a meeting set with County officials to discuss the budget process further on 3/15/19.
- St. Vincent Upper Payment Limit (UPL) Update Last year the ADAMHS Board of Directors agreed to enter into an intergovernmental transfer so that St. Vincent Charity Medical Health Center would be able to pull down the upper payment limit on Medicaid. As a result of that decision, Board staff met with the former Medicaid Director. Earlier today, Board staff participated in a conference call with current Medicaid staff to express our support of St. Vincent's UPL.
- MetroHealth Collaboration Board staff has been meeting with MetroHealth's Legislative and External Affairs staff around potential collaborative efforts. Another meeting was held with Jane Platen who represented President & CEO Akram Boutros recently to consider collaborative efforts going forward. Topics included where there are gaps in service, MetroHealth's partnership with Recovery Resources, etc. Hospital staff recognize that many of the people they serve may also have a mental health or addiction issue. Another meeting is scheduled for next month.
- Progressive Senor Leadership Presentation Video Beth Zietlow-DeJesus recently sent Board members a link to view Progressive's video presentation made to Board staff and several Board members.
- Scott noted that the ADAMHS Board intends to produce a video for our 10th Year Anniversary to be shown at our Annual Meeting on May 13, 2019. Tentative plans are to have our videographer present at the March General Meeting to tape portions of the meeting and to interact one-on-one with Board members afterward regarding their experience with the Board and its activities.

10. OLD/NEW BUSINESS

- Ms. Kern-Pilch commended Mr. Osiecki on his innovative creation of the Peer Seal of Approval program to assist in reviewing residential facilities to assure safe, clean and quality housing for clients. She noted that this might serve as a model for other Boards. Mr. Osiecki added that the Board is also contracting with the Peer Support organization to make unannounced visits to residential facilities throughout the year. This endeavor will provide an opportunity for the Peer Specialists to interact with the persons living in the residential facilities.
- Rev. Gohlstin thanked all Board members for their well wishes, gifts and cards on the occasion of his 80th birthday. As not everyone was able to attend his special party, he invited everyone in attendance to enjoy the Jambalaya that he prepared for all.
