Ms. Warr broached the subject of doing more in the area of employment with potential levy dollars. Ms. Boyle noted that during her tenure on the Board there has not been much of an opportunity to talk about the larger policy issues around funding priorities. She felt that the outcome of the levy vote, one way or the other, will necessitate the need for making decisions and setting priorities for available funds. Ms. Cash agreed that such future discussions are needed either through a Board committee or by the full Board.

7. CHIEF EXECUTIVE OFFICER'S REPORT

On behalf of Mr. Denihan, Ms. Harper referred Board members to the items featured in the CEO Headliners dated September 25, 2013 (attached to minutes).

• Bed Day Report – On behalf of Dr. Garrity who is in Columbus, Ms. Harper noted that the Bed Day Report distributed serves as a follow-up to a request around the reasons for the decrease in Cuyahoga State Hospital Civil Bed Days.

A discussion followed whether the length of stays are now too short for the needs of some consumers. Dr. Delos Reyes believes the philosophy that consumers should receive treatment in the least restrictive setting and that effort to stabilize and link consumers with community treatment is the best option for most individuals. For acute care needs, she felt that a longer stay is not necessarily the best option. Dr. Delos Reyes noted further that a potential reduction of state hospital bed days might occur if a long-term civil client is discharged to a residential facility, for instance.

Dr. Biegel noted that his original concern was not with the gradual decrease over the years but with the drastic decrease from SFY2012 to SFY2013. He would expect that this reduction would show an increase in the amount of community-based services delivered or people falling through the cracks. Ms. Boyle noted that the report would be more helpful if it included the actual numbers that could be used for advocating for additional levy dollars.

Ms. Harper noted that additional staffs were placed in residential treatment facilities that serve as step-down alternatives for people discharged from the hospital. Ms. Harper also recognized the efforts of provider agencies and ADAMHS Board staff for their work to link consumers of mental health services to community treatment prior to their discharge. Board staff will attempt to paint a clearer picture of the impact of such initiatives on state hospital bed day utilization. Ms. Saffran asked whether recidivism rates were impacted as well. Board staff will follow-up by adding numbers to the report. Ms. Thoms felt that this type of data can help in a variety of ways – promoting levies, showing how efficiencies were improved and how better care was provided with less money.

9. NEW BUSINESS

Dr. Biegel noted that soon the insurance exchanges under the Affordable Care Act will be implemented on 10/1/13. As we begin to receive data, over the next few months, about those who have signed up in Ohio along with their characteristics, he advocated for sharing this information with Board members as it will have potential implications for the mental health system in our state and county.

10. AUDIENCE INPUT

• Greg Uhland, Executive Director of ORCA House, shared that in the area of discharge planning, addiction service agencies are also very involved with discharge planning and linking clients needing residential treatment.

- Jennifer Kruse, Executive Director of the Living Miracles Peer Empowerment Center, extended her gratitude to the ADAMHS Board for their support of peer support program. When the Living Miracles broke away from Bridgeway in 2009, it had 160 consumers enrolled; the program has grown to 326 people enrolled. One impressive outcome is that 96% of the group has not returned to the hospital for treatment since becoming active members. Three individuals from the Living Miracles—Brian, LeeAnn, and Don—provided very moving testimonies about their participation with the group, what they contribute, what benefits they have realized in their recovery and thanked the ADAMHS Board for their life-changing outcome.
- After listening to the previous testimonies, Board member, Richard Romaniuk, was reminded of an independent movie
 he recently viewed about similar stories in the 1980's in Europe, entitled "We Can Do It".
