1. CALL TO ORDER

Steve Killpack, Finance & Operations Committee Chair, called the meeting to order at 4:00 p.m.

2. APPROVAL OF MINUTES

The minutes of the July 18, 2018 Joint Planning & Finance Committee were approved as submitted.

3. EARLY CHILDHOOD MENTAL HEALTH (ECMH) RECOMMENDATIONS FOR CY2019

Linda Torbert, Director of Prevention & Children's Behavioral Health Programs, reported that nine agencies submitted proposals in response to the Request for Proposal (RFP) for ECMH Services. The RFP Review Committee, comprised of ADAMHS Board staff, Invest in Children, Bright Beginnings, Cuyahoga County Board of Developmental Disabilities and Starting Point, evaluated all eligible submissions and agreed on recommending the 6 agencies listed below for the provision of ECMH services. Ms. Torbert noted that Pipe Line to God, is a new provider agency.

4. <u>CUYAHOGA COUNTY JUVENILE COURT INTERVENTION CENTER FOR BEHAVIORAL HEALTH SERVICES RECOMMENDATION</u>

Ms. Torbert reported that the Cuyahoga County Juvenile Court (CCJC) invited the ADAMHS Board to participate in the planning process for an Intervention Center to serve all pre-adjudicated youth. The goal is to limit or prevent deeper penetration into the juvenile justice system as an alternative to detention intervention. Eight agencies submitted proposals. Based upon the review and evaluation by the RFP Committee, comprised of staff from the ADAMHS Board and CCJC, of all proposals submitted, the resulting decision was to recommend contracting with Applewood Centers, Inc. for this program.

Ms. Torbert addressed questions of Board members. A suggestion was made to include in the outcome portion of the agenda process sheet best practice outcomes as well as comparison data from Lucas and Montgomery Counties.

Motion to recommend accepting funds from the CCJC and to contract with Applewood Centers, Inc. for the CCJC Intervention Center Behavioral Health Services Program to the full Board. MOTION: S. 5. <u>US DHHS (DEPARTMENT OF HEALTH & HUMAN SERVICES) SUBSTANCE ABUSE & MENTAL HEALTH</u> SERVICES ADMINISTRATION (SAMHSA) CENTER FOR MENTAL HEALTH SERVICES – JAIL DIVERSION GRANT

Carole Ballard, Director of Education and Training, explained that the Jail Diversion Grant award represents the first year of a five-year project totaling \$1 million. The pilot project would expand resource options for Crisis Intervention Training (CIT) officers by having access to other alternatives to jail such as the use of the Crisis Stabilization beds operated by FrontLine Service. Direct services will be delivered by FrontLine Service, and the Board will contract with the Case Western Reserve University's Begun Center for Violence Prevention, Research and Education (CWRU) for federally required evaluation and performance assessment services.

Ms. Ballard noted that a workgroup will be charged with the task of forming and shaping the pilot project. Discussion followed on the evaluation and/or outcome data anticipated and the request of Board members to include this information on the agenda process sheet (APS). A separate Board member request was to utilize numerical values so that specific results can be measured and assist Board members in evaluating the accomplishments of a project or program. Ms. Ballard confirmed that evaluation/outcome data will be added to revise the APS prepared for the full Board.

Motion to recommend accepting funds from SAMHSA and to contract with FrontLine Service in the amount of \$260,340.00 and the CWRU Begun Center in the amount of \$66,000.00 for the first year of a five year project to the full Board. 6. <u>DISCUSSION: OHIO ISSUE 1: DRUG & CRIMINAL JUSTICE POLICIES INITIATIVE</u>

Board Chair, Rev. Gohlstin, explained that Ohio Issue 1 started out as a grassroots community concern regarding the disparity and treatment of people incarcerated for possessing drugs. As legislators will soon consider the issue of possession of marijuana, community organizers felt that an amendment to the Constitution may be needed to address the issue of sentencing.

Rev. Gohlstin reported that the language of the amendment was subsequently changed at the state level; he no longer supports the amendment as presented. Scott Osiecki, CEO, added that local courts and judges are also not in favor of the amendment as written. To date, the Ohio Association of County Behavioral Health Authorities (OACBHA) has not yet taken a position on Issue 1. Rev. Gohlstin reiterated that the Secretary of State's proposed language on the ballot does not reflect the original intent of those who brought the issue of concern forward. It was noted that this issue will be discussed again at the September General Meeting.
