Amendment to Resolution 19-11-08, Briermost Foundation and Sober Living Cleveland Contracts for the time period September 1, 2020 through December 31, 2020 to decrease funding for Sober Living Cleveland by the balance of the contract (up to \$6,666.70) and to transfer said allocation to Briermost Foundation due to the merger of the two entities effective September 1, 2020; and,
- 3. Amendment to Resolution 19-09-06, OhioMHAS: Addiction Treatment Program (ATP) to extend the time period until June 30, 2021 and to utilize approved Carryover funds in the amount of \$805,012.35 using a pooled funding mechanism with the following provider agencies:

- 5. Amendment to Resolution 19-11-08, Cuyahoga County Domestic Relations Court for the time period January 1, 2020 through December 31, 2020 to increase funding by \$15,000.00. All other terms of the contract remain the same; and,
- 6. Amendment to Resolution 20-07-03, OhioMHAS: K-12 Prevention Education Initiatives to reallocate \$10,000.00 of funding between providers by reducing the contract for Cleveland Rape Crisis to \$26,591.80 and increasing the contract for Beech Brook to \$106,311.80.
