## New City of Cleveland Co-Responder Team Will Respond to 911 Mental Health Crisis Calls

The Cleveland Division Police and partners from the ADAMHS Board, FrontLine Service, Murtis Taylor and Case Western Reserve University have been working together to implement a co-responder team in Cleveland. These programs allow for law enforcement officers and social workers to work together in a Co-Responder Team (CRT) and respond to crisis calls. The Bureau of Justice Assistance (BJA) awarded the City of Cleveland a grant in the amount of \$523,800 and the ADAMHS Board provides \$333,950 in additional funding to make CRTs possible in Cleveland. The Cleveland Division of Police and partners launched the new CRTs on October 19, 2020 for two weeks of training, which included crisis response role plays. Once training is complete, the teams will hit the streets beginning Monday, November 2. Every police district will have at least one Co-Responder Team to respond to mental health crisis calls generated through 911. This is a great example of the police and behavioral health care professionals working together to keep individuals in crisis out of jail and receiving the care they need.

# Next Work Group Meeting on Eliminating Structural Racism in Behavioral Health is November 2

Thank you to everyone who joined us on October 5 for our first work group meeting to address structural racism in behavioral health care. The first meeting included a review of Resolution No. 20-06-01 Declaring Racism a Public Health Crisis, a brainstorming session and decisions about the group structure and when meetings will be held.


# ADAMHS Board and Cleveland Division of Police Co-Hosted a Virtual Coffee with a CIT Officer

## Caring for the Caregivers Summit Will Be Held November 6 and 7

November is National Family Caregivers Month, and **Courage to Caregivers** is holding a free two-day virtual event for professional and family caregivers who serve individuals living with mental illness. The summit will feature interactive workshops by professional facilitators focusing on connectedness, empowerment, and self-care for caregivers. The event will take place on November 6 (10 a.m. to 2:30 p.m.) for professional caregivers and November 7 for family caregivers (10 a.m. to 3 p.m.). On day one, professional caregivers can earn 4.5 FREE CEUs/RCHs for attending, which are sponsored by the ADAMHS Board. Click here to register for one or both days of this free summit.

### **Crisis Intervention Team Trainings**



The ADAMHS Board recently provided two Crisis Intervention Team trainings. The first trained 16 officers from Richmond Heights, Cleveland Metropolitan Housing Authority (CMHA), Bay Village, Lakewood, Cleveland Metroparks, Strongsville, University Hospitals, University Circle and Greater Cleveland RTA. The ADAMHS Board also hosted the first new 40-hour Specialized CIT training for the Cleveland Division of Police. A total of 19 officers (pictured above) representing all five districts and the airport were trained. Both trainings were supported by our behavioral health partner agencies in the community. The training was presented through a hybrid model using Zoom and face-to-face with social distancing.

### Update on Phase One of the Opioid Settlement Projects

The ADAMHS Board contracted with **Thrive Behavioral Health** for the Thrive ED Program to provide 24-Hour peer support services to individuals who have been revived from an opioid overdose in **University Hospitals** and **Cleveland Clinic** Emergency Departments. Thrive has been actively recruiting, hiring and onboarding peer recovery coaches for the program. Thrive ED is up and running in all six University Hospital Emergency Departments as of July 1, with services provided virtually. On November 1, in-person services will begin in the Parma Emergency Department.

The ADAMHS Board also contracted with **Stella Maris** for Intensive Outpatient Program (IOP), Partial Hospitalization Program (PHP) and Residential Treatment. Stella Maris has been hiring and onboarding the necessary personal and is working to purchase the former Matt Talbot Inn. The Inn will be used to house the entire 32-bed residential program. (Opioid Settlement Projects continued)... Stella Maris opened a newly built detox facility in September, which allowed Stella Maris to launch the new Residential Treatment program for 12 men temporarily in the former building used for detox, while the Matt Talbot property is being renovated.

The ADAMHS Board contracted with **St. Vincent Charity Medical Center's Rosary Hall** for Peer Support, IOP/PHP and 24-hour Intake. St. Vincent has worked to hire necessary personnel, and is collaborating with **Catholic Charities** to provide PHP/IOP to Catholic Charities' residential clients,in addition to expanding outpatient services.

### **Meetings of Note**

Scott S. Osiecki, CEO, met with Council President Dan Brady to review the county's budget, effects of the pandemic in the county and the opioid settlement dollars. Late in September, Scott also met with Councilwoman Yvonne Conwell, who has been a staunch advocate for behavioral health services in Cuyahoga County, related to the same topics. The ADAMHS Board values its partnership with Cuyahoga County Council.

At the October 20 **ADAMHS Board All Provider Meeting**, Scott informed agency representatives about the CY2021 ADAMHS Board budget process and the uncertainty of dollars being allocated to the ADAMHS Board in 2021. During the meeting, providers also discussed valuable resources, such as eviction assistance, the upcoming **Courage to Caregivers Summit** and the work group to eliminate racism in behavioral healthcare. Mr. Osiecki also thanked providers for their diligence to serving Cuyahoga County residents despite the pandemic and for quickly embracing the adjustments that had to be made.

# Educating the Community About the Danger of Fentanyl

**Scott S. Osiecki**, CEO, interviewed with **Channel 19 News** about the impact of the pandemic on overdoses in Cuyahoga County as well as in response to a deadly overdose weekend in early October.

Scott provided information about the ADAMHS Board's grassroots fentanyl test strip distribution program and its focus on targeting cocaine users who may not know they are getting fentanyl. The deadly overdose weekend included more than 20 overdoses, most related to fentanyl mixed with cocaine and predominately in communities of color.

"We don't condone drug use. We want people to know what drugs they are using so they can live long enough to get into treatment and live in recovery. These are not just statistics, they are our family members and friends that are dying," said Scott.
