Client-Centered Funding Strategy for Mental Health and Addiction Treatment Services

Since Medicaid Expansion and Behavioral Health Redesign, mental health and addiction treatment services for more and more individuals are being covered. The ADAMHS Board has found that there is no longer a need to allocate and encumber funding by agency for treatment services.

Agencies providing treatment services will not receive a specific allocation. The treatment services for individuals who are not eligible or waiting for Medicaid will be paid from a pooled funding source through fee for service billing. The available pool of funding was determined by CY20 treatment funding usage. The ADAMHS Board will monitor the funding pool through monthly utilization reviews.
