WHEREAS, funding has been made available to the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) for the following programs:

1. Community Transition Program (CTP) funding for the time period July 1, 2020 to June 30, 2021 in the amount of \$744,590.61 (SFY2021 Allocation \$500,000.00; SFY2020 Carryover funds \$244,590.61) for the following contract:
 - a. FrontLine Service; and,
2. State Opioid Response (SOR) High Risk Families Grant funding from OhioMHAS for the time period September 30, 2020 to September 29, 2021 in the amount of \$953,852.42 for the following contracts:
 - a. Catholic Charities - \$375,764.00
 - b. Cuyahoga County Department of Children Family Services - \$1,480.00
 - c. Mommy and Me, Too! - \$469,376.22
 - d. Hitchcock Center for Women - \$72,877.20
 - e. Signature Health - \$34,355.00; and,
3. State Opioid Response (SOR) Minority Communities Grant funding from OhioMHAS for the time period September 30, 2020 to September 29, 2021 in the amount of \$957,500 for the following contracts:
 - a. Cleveland Treatment Center - \$331,600
 - b. Cleveland UMADAOP - \$232,448
 - c. Hispanic UMADAOP - \$94,748
 - d. Hitchcock Center for Women - \$298,704; and,
4. Consulting Contract – ADAMHS Board Disparity and Equity Initiative for the time period January 1, 2021 to December 31, 2021 in the amount of \$60,000 for the following contract:
 - a. Jeffrey D. Johnson, Attorney-at-Law; and,
5. Security Services Contract for the time period January 1, 2021 to December 31, 2021 in the amount of \$150,695 (\$20.65 per hour) for the following contract:
 - a. Willo Security; and,
6. Second Chance Act Addressing the Needs of Incarcerated Parents and Their Minor Children Program from the U.S. Department of Justice (DOJ) Bureau of Justice Assistance, Office of Juvenile Justice and Delinquency Prevention (OJJDP) funding for the time period October 1, 2020 to September 30, 2023 in the amount of \$745,969. A 50% match is provided by the ADAMHS Board through the funding of the Healthy Families Program at Oriana House. The funding is for the following contracts:
 - a. Oriana House - \$372,984
 - b. FrontLine Service - \$372,985; and,

WHEREAS, the Committee of the Whole has reviewed the ADAMHS Board staff's recommendation and recommend that the Board of Directors accept the funding and authorize the ADAMHS Board to pay the required local match and enter into any necessary contractual agreements.

NOW, THEREFORE, BE IT RESOLVED:

A. The ADAMHS Board of Directors accepts the funds and authorizes payment of any required local match for the following:

1. Community Transition Program (CTP) funding for the time period July 1, 2020 to June 30, 2021 in the amount of \$744,590.61 (SFY2021 Allocation \$500,000.00; SFY2020 Carryover funds \$244,590.61) for the following contract:
 - a. FrontLine Service; and,
2. State Opioid Response (SOR) High Risk Families Grant funding from OhioMHAS for the time period September 30, 2020 to September 29, 2021 in the amount of \$953,852.42 for the contracts:
 - a. Catholic Charities - \$375,764.00
 - b. Cuyahoga County Department of Children Family Services - \$1,480.00
 - c. Mommy and Me, Too! - \$469,376.22
 - d. Hitchcock Center for Women - \$72,877.20
 - e. Signature Health - \$34,355.00; and,
3. State Opioid Response (SOR) Minority Communities Grant funding from OhioMHAS for the time period September 30, 2020 to September 29, 2021 in the amount of \$957,500 for the following contracts:
 - a. Cleveland Treatment Center - \$331,600
 - b. Cleveland UMADAOP - \$232,448
 - c. Hispanic UMADAOP - \$94,748
 - d. Hitchcock Center for Women - \$298,704; and,
4. Consulting Contract – ADAMHS Board Disparity and Equity Initiative for the time period January 1, 2021 to December 31, 2021 in the amount of \$60,000 for the following contract:
 - a. Jeffrey D. Johnson, Attorney-at-Law; and,
5. Security Services Contract for the time period January 1, 2021 to December 31, 2021 in the amount of \$150,695 (\$20.65 per hour) for the following contract:
 - a. Willo Security; and,
6. Second Chance Act Addressing the Needs of Incarcerated Parents and Their Minor Children Program from the U.S. Department of Justice (DOJ) Bureau of Justice Assistance, Office of Juvenile Justice and Delinquency Prevention (OJJDP) funding for the time period October 1, 2020 to September 30, 2023 in the amount of \$745,969. A 50% match is provided by the ADAMHS Board through the funding of the Healthy Families Program at Oriana House. The funding is for the following contracts:
 - a. Oriana House - \$372,984
 - b. FrontLine Service - \$372,985.

B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary contractual agreements.
