### Cuyahoga County Diversion Center Announced, ADAMHS Board to Manage Center, Partnering with Oriana House and FrontLine Service!

On Friday, November 20, Cuyahoga County Executive **Armond Budish** announced he is submitting a request to County Council for funds not to exceed \$9.2 million to enter into contract with the ADAMHS Board to operate a Diversion Center in Cuyahoga County, transforming the justice system. This Diversion Center would be the first-of-its-kind in Ohio to work in conjunction with the justice system to allow those committing low-level offenses to receive the help, care and resources they need in a medical environment rather than within the County jail. The Diversion Center will be located at the **Oriana House** on E 55<sup>th</sup> Street in Cleveland and is slated to open in 2021. Local law enforcement will complete Crisis Intervention Team (CIT) training, which will give officers the tools needed to identify someone with mental health and/or substance abuse issues and provide them with communication tools to appropriately handle the situation. Officers will also be able to call a 24-hour hotline staffed by **FrontLine Service** to help make the determination if an individual is a good candidate for the Diversion Center. The ADAMHS Board extends its gratitude to the many partners who have been working towards this goal and ensuring that individuals with mental health and substance issues get the help they need rather than go to jail. We are excited to partner with the County on this endeavor.

#### Coping with the Holidays and a Pandemic Brochure Released

The ADAMHS Board, in partnership with the **Cuyahoga County Suicide Prevention Coalition**, updated its annual booklet and renamed it **Coping with the Holidays and a Pandemic.** This booklet offers tips on reducing extra stresses of the holiday season as well as the prolonged stress we have all felt because of the pandemic. This holiday season will be different from years past. The pandemic is forcing us to be flexible and find new ways we can celebrate safely. New additions to this year's brochure include, tips for helping children cope; how to celebrate with older family and friends safely; creative ways to celebrate virtually; and safety precautions to consider. There is even a coloring page and word search for kids (or adults) in this year's brochure!


#### Mental Health and Substance Use Disorder **Collaborative Community Awareness Campaign Underway in Cuyahoga County**

The project is funded with a grant from the Cleveland Foundation. Many agencies work to educate the community about mental health and substance use needs, services, and the negative consequences of stigma, but convening stakeholder organizations to develop a coordinated awareness campaign and pooling resources will have a greater impact. #### Cuyahoga County Proposes \$4.1 Million Increase to ADAMHS Board Base Health and **Human Services Levy Allocation**

In November, the ADAMHS Board was notified that the County proposed an increase to its base allocation from the Health and Human Services levy by \$4.1 million annually. The County asked the Board to focus the use of this money on mental health and addiction crisis services, suicide prevention and residential/housing initiatives.

On November 16, **Scott S. Osiecki**, CEO, presented the Board's programming ideas in the designated areas. The discussion included increasing the number of co-responder teams in Cuyahoga County as well as expanding Crisis Intervention Team (CIT) training and the Crisis Services System with new crisis beds for children and trauma services for victims of crime.

The proposed funding increase will be voted on by County Council in December. If approved, the ADAMHS Board will expand its harm reduction efforts including the grassroots fentanyl test strip program, implementing a NaloxBox plan and launching suicide prevention public awareness campaigns. The money will allow the ADAMHS Board to increase its residential services for special populations such as pregnant women, women/men with children, youth and transitional aged-youth.

"The ADAMHS Board of Directors and staff extends its sincere gratitude to the residents of Cuyahoga County for overwhelmingly passing the Levy earlier this year," said Scott S. Osiecki. "The County Executive and County Council have shown their support by ensuring this much-needed funding is in place to help address critical issues in our community for people living with mental illness and substance use disorders."

At the November 18 General Board meeting, the Board of Directors unanimously approved the Five-Year Strategic **Plan**. The plan, which will be implemented from 2021-2025, includes six main strategic goals: Strengthening Service Delivery, Measuring Impact, Maximizing Available Funding, Maintaining a High-Performing Organization, Strengthening Behavioral Health Workforce, and Sharing Information.

## ADAMHS Board's Director of External Affairs Serves as Mentor in Cleveland State University Mentoring Program
