 - b. Cuyahoga Community College - \$40,000.00
 3. Crisis Stabilization Beds funding for the time period January 1, 2021 to December 31, 2021 in the amount of \$600,000.00 for the following contract:
 - a. Applewood Centers, Inc.; and,
 4. Parole Assertive Community Treatment (PACT) funding from Ohio Department of Rehabilitation and Corrections (ODRC) for the time period July 1, 2020 to June 30, 2021 in the amount of \$275,000.00 for the following contract:

 9. Cuyahoga County NaloxBox Initiative for the time period January 28, 2021 to December 31, 2021 in the amount of \$75,000.00 for the following contracts:

 10. WOVU 95.9 FM Radio Partnership for the time period January 28, 2021 to January 31, 2022 in the amount of \$20,000.00 for the following contract:

a. Burton, Bell, Carr Development, Inc.
