  - a. Oriana House - \$1,078,389; and,
3. Mental Health Court Program (MHCP) funding from OhioMHAS for the time period July 1, 2020 to June 30, 2021 in the amount of \$10,345.00 for the following contracts:
  - a. Cleveland Municipal Court - \$5,172.50
  - b. South Euclid Municipal Court - \$5,172.50; and,
4. Galilean Theological Center (GTC) Substance Use Disorders Education & Training Program for Latinx Clergy & Church Leaders funding for the time period January 1, 2021 to December 31, 2021 in the amount of \$60,000.00 for the following contract:
  - a. Galilean Theological Center.

B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary contractual agreements.
