**WHEREAS**, funding has been made available to the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) for the following programs:

    - 1) Recovery Resources
  - c. Early Intervention Program (EIP) - \$231,000
    - 1) Community Assessment & Treatment Services (CATS)
  - d. Co-Occurring Residential Treatment for Men - \$160,000
    - 1) Catholic Charities/Matt Talbot for Men
  - e. Intensive Outpatient Treatment (IOP) for Intensive Service Probationers (ISP) - \$50,000
    - 1) Catholic Charities/Matt Talbot; and
2. Continuation and Enhancement of NEO Collaborative SAMHSA Supplemental Emergency COVID-19 Funds for the time period July 1, 2021 to March 31, 2022 in the amount of \$457,270 for the following contracts:
  - a. FrontLine Service - \$62,133
  - b. Northeast Ohio Black Health Coalition - \$10,000
  - c. NEO Collaborative Marketing Campaign - \$76,230
  - d. NEO Collaborative Boards - \$308,907
    - 1) Lorain County Mental Health Addiction and Recovery (MHARS) Board - \$72,133
    - 2) Lake County ADAMHS Board - \$72,133
    - 3) Geauga County Board of Mental Health and Recovery Services - \$72,133
    - 4) Ashtabula Count Mental Health & Recovery Services Board - \$63,505
    - 5) Summit County ADM Board - \$29,003; and,

**WHEREAS**, the Planning & Oversight Committee and the Finance & Operations Committee have reviewed the ADAMHS Board staff's recommendation and recommend that the Board of Directors accept the funding and authorize the ADAMHS Board to pay any required local match and enter into any necessary contractual agreements.

**NOW, THEREFORE, BE IT RESOLVED:**

- A. The ADAMHS Board of Directors accepts the funds and authorizes payment of any required local match for the following:

    - 1) Recovery Resources
  - c. Early Intervention Program (EIP) - \$231,000
    - 1) Community Assessment & Treatment Services (CATS)
  - d. Co-Occurring Residential Treatment for Men - \$160,000
    - 1) Catholic Charities/Matt Talbot for Men
  - e. Intensive Outpatient Treatment (IOP) for Intensive Service Probationers (ISP) - \$50,000
    - 1) Catholic Charities/Matt Talbot; and
2. Continuation and Enhancement of NEO Collaborative SAMHSA Supplemental Emergency COVID-19 Funds for the time period July 1, 2021 to March 31, 2022 in the amount of \$457,270 for the following contracts:
  - a. FrontLine Service - \$62,133
  - b. Northeast Ohio Black Health Coalition - \$10,000
  - c. NEO Collaborative Marketing Campaign - \$76,230
  - d. NEO Collaborative Boards - \$308,907
    - 1) Lorain County Mental Health Addiction and Recovery (MHARS) Board - \$72,133
    - 2) Lake County ADAMHS Board - \$72,133
    - 3) Geauga County Board of Mental Health and Recovery Services - \$72,133
    - 4) Ashtabula Count Mental Health & Recovery Services Board - \$63,505
    - 5) Summit County ADM Board - \$29,003.

B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary contractual agreements.
