**WHEREAS**, funding has been made available to the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) for the following programs:

1. Adverse Childhood Experiences (ACEs) 2022 Awareness Video Series for the time period November 18, 2021 to December 31, 2022 in the amount of \$3,000 for Social Media Ads; and,
2. Security Services Contract for the time period January 1, 2022 to December 31, 2022 in the amount of \$159,623 (\$21.89 per hour) for the following contract:
  - a. Willo Security; and,
3. Children's Residential Staffing Crisis for the time period December 1, 2021 to June 30, 2022 in the amount of \$250,000 for the following contract:
  - a. OhioGuidestone; and,
4. CIT Training Supplemental Contracts for the Diversion Center for the time period January 1, 2022 to December 17, 2022 in the amount of \$63,350 for the following contracts:
  - a. Traumatic Players of Cleveland, Inc. - \$19,800
  - b. Cuyahoga Community College - \$43,550; and,

**WHEREAS**, the Committee of the Whole reviewed the ADAMHS Board staff's recommendation and recommend that the Board of Directors accept the funding and authorize the ADAMHS Board to pay any required local match and enter into any necessary contractual agreements.

  2. Security Services Contract for the time period January 1, 2022 to December 31, 2022 in the amount of \$159,623 (\$21.89 per hour) for the following contract:
    - a. Willo Security; and,
  3. Children's Residential Staffing Crisis for the time period December 1, 2021 to June 30, 2022 in the amount of \$250,000 for the following contract:
    - a. OhioGuidestone; and,
  4. CIT Training Supplemental Contracts for the Diversion Center for the time period January 1, 2022 to December 17, 2022 in the amount of \$63,350 for the following contracts:
    - a. Traumatic Players of Cleveland, Inc. - \$19,800
    - b. Cuyahoga Community College - \$43,550.

B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary contractual agreements.
