WHEREAS, the ADAMHS Board of Cuyahoga County develops and approves an Advocacy Action Agenda each year to focus its efforts and develop messages to legislators, state agencies, policy makers, clients, families, providers and the general public to advance important behavioral health issues; and,

WHEREAS, at the beginning of each year, the prior year's Advocacy Action Agenda is reviewed by the Community Relations and Advocacy Committee to determine success, a new agenda is set and recommended to the full Board by the Committee for the current year; and,

WHEREAS, the Advocacy Action Agenda for 2021 was developed with the over-arching goal of promoting recovery of individuals living with mental illness and addictions by adopting and acting on the six 2021-2025 Strategic Plan Goals, which align with the Recovery Oriented System of Care principles:

- 1. Strengthening Service Delivery System
- 2. Measuring Impact
- 3. Maximizing Available Funding
- 4. Maintaining a High-Performing Organization
- 5. Strengthening Behavioral Health Workforce
- 6. Sharing Information; and,

WHEREAS, the Advocacy Action Agenda is in addition to the advocacy and collaboration that the Board provides on a daily basis through its work of ensuring that mental health, addiction treatment and prevention and recovery services and supports are available to help children and adults reach and sustain recovery; and,

WHEREAS, adoption and implementation of the 2021 Advocacy Action Agenda will help facilitate the implementation of the Recovery Oriented System of Care by focusing Board efforts, activities, decisions and funding to advance recovery issues and initiatives.

Overarching Advocacy Objectives for 2021:

The Alcohol, Drug Addiction and Mental Health Services (ADAMHS) Board of Cuyahoga County has developed this *Advocacy Action Agenda* to guide its advocacy efforts for 2021. This agenda was developed with the overarching goal of promoting recovery of individuals living with mental illness and substance use disorders by adopting and acting on the six 2021-2025 Strategic Plan Goals, which align with the Recovery Oriented System of Care principles:

- 1. Strengthening Service Delivery System.
- 2. Measuring Impact.
- 3. Maximizing Available Funding.
- 4. Maintaining a High-Performing Organization.
- 5. Strengthening Behavioral Health Workforce.
- 6. Sharing Information.

The ADAMHS Board uses the Advocacy Action Agenda to develop messages to legislators, state agencies, policy makers, clients, families, providers and the general public to advance important behavioral health issues, such as Racism as a Public Health Crisis, COVID-19, the opioid epidemic, suicide prevention efforts and best practices in treatment and recovery support services.

Goals:

- NEW Expand co-responder team programs to help connect individuals with mental health and substance use disorders to treatment rather than jail.
- NEW Support programs that reach underserved populations identified in the 2020 Needs Assessment, including transitionalaged youth, pregnant women and single parent families with children.
- NEW Advocate for and support provider agencies' use of a broader range of treatment modalities, specifically including models for diverse communities.
- NEW Support efforts to ensure that culturally competent and specific programs are in place to address structural racism in Cuyahoga County's behavioral health care system.
- NEW Educate providers about new efforts at the Board related to compliance and outcomes data collection.

- NEW Support trauma-informed resources and care for peer support specialists, recovery coaches, behavioral health care workers and first responders to reduce the effects of secondary trauma.
- NEW Increase Crisis Intervention Training for Officers in Cuyahoga County as part of Diversion Center efforts.
- NEW Direct social media and advertisements to diverse populations to increase awareness of mental health issues and substance use disorders, available resources for care and training.
- NEW Manage effective programs at the Diversion Center and advocate for law enforcement to use it.
- NEW Support efforts to increase access to high-quality housing for individuals with mental illness and/or substance use disorders for specialized populations (i.e. youth, pregnant women, single parent families with children, transitional-aged youth and homeless persons).
- NEW Strengthen the understanding of media and providers about recovery and best practices in public health messaging to reduce stigma and educate the community about mental health and substance use disorders.
- NEW Implement Community NaloxBox Plan, support efforts to combat the evolving fentanyl/opioid epidemic and respond to rising stimulant abuse trends.
- NEW Communicate importance of behavioral health in daily life
 to generate interest in working in the behavioral health field
 and educate middle school, high school and college students
 about career opportunities in behavioral health.
- Develop a Crisis Intervention Policy for the community behavioral health system detailing what Crisis Intervention Team (CIT) officers can expect from our provider network.
- Share legislative updates that impact individuals and families living with mental illness and/or addictions and the behavioral health system with providers and the public.
