2018 ADAMHS Board Budget

Valeria A. Harper, Chief Executive Officer of the ADAMHS Board presented the Calendar Year 2018 funding recommendations to the Board on November 15. This proposal was a working document that contained information our Board will need to make an informed decision on whether to approve the document as is or with recommend changes. This decision will be made by the end of the year.

The Board's overall budget remains slightly over \$67 million. However, the Board will be strained to continue to support individuals in need of mental health and addiction recovery services at the current level, particularly for services that are not covered by insurance, during the midst of combating this opioid epidemic.

In preparing the 2018 budget recommendation, the following was considered:

- The County Executive has designated \$39 million in funding from the Health & Human Services levies for Calendar Years 2018 & 2019. This is the same level of funding that the Board received in Calendar Years 2016 & 2017.
- The \$3.5 million in discretionary State funding for prevention, mental health and addiction treatment and recovery support services, is \$5 million less than we were receiving four years ago.
- There is \$6.8 million in discretionary Federal grant funding available to the Board.

For these reasons, a recommendation was made to our Board to only enter into one-year contracts with provider agencies for Calendar Year 2018. Even after reducing our administration budget by \$300,000 or 5.3%, it will not be possible for the Board to support all of the programs previously funded in 2016 & 2017.

The Mental Health and Addiction Advocacy Coalition (MHAC) organized a variety of providers, clients and family members to provide testimony to Cuyahoga County Council on November 27. The advocates spoke on the importance of funding to the ADAMHS Board to maintain valuable recovery support services.

Take Charge Ohio Campaign Launched at ADAMHS Board

Valeria A. Harper, Chief Executive Officer of the ADAMHS Board was pleased that the Ohio Department of Health selected the ADAMHS Board offices to launch the Take Charge Ohio Campaign in the Cleveland area. As she opened the press conference on November 28, she stated "It is only fitting that we are able to host this launch since the Board is a partner in combating the opioid/heroin crisis in our community."

Ms. Harper briefly **shared some highlights** of the efforts that the ADAMHS Board is doing here in Cuyahoga County to address the crisis. After touching on the highlights she mentioned that the **Board is equally eager to be a partner**

with the Ohio Department of Health to spread the word through the Take Charge Ohio Campaign to inform our residents about the dangers of misusing prescription pain medication and how to safely manage pain.

The *Take Charge Ohio* Campaign was developed to help opioid prescribers educate their patients and the public about the dangers of misusing prescription pain medication and how to safely manage pain. The campaign is grant funding from the Centers for Disease Control and Prevention and was developed in partnership with several state agencies and boards that are members of the Governor's Cabinet Opiate Action Team. ADAMHS Board Employee Highlight: Tom Williams

Tom Williams is the Evaluation and Research Officer for the ADAMHS Board. He began working with the Alcohol and Drug Addiction Services Board (ADAS Board) in January of 2002 and became part of the ADAMHS Board after the 2009 consolidation. Tom is a dedicated employee, whose expertise in data evaluation of program outcomes helps the Board identify best practices and areas with room for improvement.

In his day-to-day duties, Tom evaluates programs based on results; works with a "great team" of people to integrate the SHARES system; and, provides technical assistance to providers as they work with program data. Once a math teacher, Tom enjoys helping people understand data and how it can be used to enhance programming. He recalled a time when the data at a Detox Center showed marked improvement in retainment rate of its clients. He shared the data with the organization and asked what they had done differently during that time frame. It turned out they were physically walking the clients down the hall to their next level of treatment. That small change made a significant positive outcome change for the program. It is examples like that one that Tom said are the best rewards for his work.

Tom said the most challenging part of his job is helping people see the value and importance of data collection and evaluation. To help overcome that barrier and improve his evaluation skills, Tom is a member of the American Evaluators Association (AEA) and sits on the Board of its local affiliate, the Ohio Program Evaluators Group. He also serves as the Co-Chair of the AEA local working group that is helping bring an international conference to Cleveland next year to cover issues on program evaluation design, data collection, evaluation implementation, results presentation and its practical use.

Tom's supervisor, **John Garrity, Ph.D.**, Chief Quality Officer says, "Tom is always positive in outlook, and is extremely dedicated. He is a thoughtful listener; patient and collaborative. He is respected as a skilled data analyst and evaluator within our local system and throughout the state. His contributions are a great asset to the ADAMHS Board, and he's a great person to work with!"

In his spare time, Tom is an assistant Scout Master with the Boy Scouts of America; enjoys hiking and backpacking in the mountains; and gardening. His proudest personal achievements are his children and grand son; and his greatest achievement at work is when he helps providers realize how the data can be used to assist clients and manage their organizations. He was honored with the 2016 Roberta O'Keefe Award by the Ohio Program Evaluator's Group (OPEG) for "Serving and Promoting OPEG in an exceptional manner." When asked what motivates him, Tom replied, "Working with a dedicated group of co-workers, who put all else aside to best serve our clients and their families."

YouthMOVE Ohio in Cuyahoga County



In 2016, the ADAMHS Board was awarded a grant through YouthMOVE Ohio to begin developing a local youth council in Cuyahoga County. The goal is to involve youth and young adults ages 14-24 with lived experiences as key stakeholders to influence system changes. YouthMOVE Ohio is a statewide youth-led organization devoted to improving services and systems to support youth inclusion, mental wellness, positive supports and healthy transitions to adulthood.

The YouthMOVE Ohio Council of Cuyahoga County is comprised of 10 Youth Leaders who meet regularly at the ADAMHS Board to provide feedback, advocacy and raise awareness about issues impacting youth, including mental health, substance abuse and child welfare. ADAMHS Board staff, Maggie Spellman, LPCC-S, Children's Behavioral Health Specialist, and Myra Henderson, LISW-S, Adult Behavioral Health Specialist II, as well as staff from the Life Exchange Center serve as Adult Supporters to the Council.

In November 2017, the YouthMOVE Ohio Council raised awareness of available crisis support services by distributing over 1,500 Crisis Text Line wristbands and other materials in eight high schools across Cuyahoga County. In 2018, the YouthMOVE Ohio Council plans to organize activities related to youth leadership development and Child Mental Health Awareness Week. Visit www.ohioyouthmove.org for more information.

October 26: 24th Annual Break The Silence... Break the Cycle Luncheon

The ADAMHS Board of Cuyahoga County attended the **Domestic Violence & Child Advocacy Center's 24**th **Annual Break the Silence...Break the Cycle luncheon** featuring domestic violence survivor and advocate, Melissa Dohmes.

October 27: Crisis Intervention in the Courtroom Web Conference

Carole Ballard, MSSA, LISW, ADAMHS Board CIT Program Officer, and a team of magistrates held a web training conference for Ohio Municipal and Common Pleas magistrates and judges to help them identify signs of rising emotions in people within the courtroom setting; avoid or diffuse escalating behavior; and, effectively deal with people who are in crisis. The conference included a panel discussion with Chief Magistrate Barbara Reitzloff and Magistrate Sandra Lewis from Cleveland Municipal Housing Court. There were 70 participants from around the state. The training was sponsored by the Supreme Court of Ohio Judicial College.
