**WHEREAS**, funding has been made available to the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) for the following programs:

1. Accepting funds for Mobile Response and Stabilization Services (MRSS) from Aetna Better Health of Ohio through the Ohio Department of Medicaid (ODM) for the time period December 31, 2021 to June 30, 2022 in the amount of \$375,000; and,
2. Accepting funds for HEALing Communities Study Public Awareness Partnership from HEALing Communities Study for the time period March 24, 2022 to December 31, 2022 in the amount of \$22,500 for public awareness campaigns/messaging; and,
3. Milestones Autism Resources Health Worker Training Program for the time period March 24, 2022 to March 31, 2023 in the amount of \$33,627 for the following contract:
  - a. Milestones Autism Resources; and,
4. Date selection and operational issues for the facilitation of the Roads to Recovery Conference: The Culture of Recovery 2022 to be held on October 17, 2022 in an amount not to exceed \$60,000; and,
5. Sponsorships:
  - a. Him and Me - \$500
  - b. Project LIFT Life Skills Summit - \$1,000
  - c. Mentally Mangled Mental Health Conference for Faith Leaders - \$1,000
  - d. LifeAct Print Materials - \$6,500; and,

**WHEREAS**, the Planning & Oversight and Finance & Operations Committees have reviewed the ADAMHS Board staff's recommendations and recommend that the Board of Directors accept the funding and authorize the ADAMHS Board to pay any required local match and enter into any necessary contractual agreements.

- A. The ADAMHS Board of Directors accepts the funds and authorizes payment of any required local match for the following:
  1. Accepting funds for Mobile Response and Stabilization Services (MRSS) from Aetna Better Health of Ohio through the Ohio Department of Medicaid (ODM) for the time period December 31, 2021 to June 30, 2022 in the amount of \$375,000; and,
  2. Accepting funds for HEALing Communities Study Public Awareness Partnership from HEALing Communities Study for the time period March 24, 2022 to December 31, 2022 in the amount of \$22,500 for public awareness campaigns/messaging; and,

3. Milestones Autism Resources Health Worker Training Program for the time period March 24, 2022 to March 31, 2023 in the amount of \$33,627 for the following contract:
  - a. Milestones Autism Resources; and,
4. Date selection and operational issues for the facilitation of the Roads to Recovery Conference: The Culture of Recovery 2022 to be held on October 17, 2022 in an amount not to exceed \$60,000; and,
5. Sponsorships:
  - a. Him and Me - \$500

  - d. LifeAct Print Materials - \$6,500; and,
