**AUTHORIZATION TO ISSUE A REQUEST FOR PROPOSAL FOR THE CUYAHOGA
COUNTY CORRECTIONS PLANNING BOARD'S ESSENTIAL BEHAVIORAL HEALTH
INTERVENTIONS & CRIMINOGENIC NEEDS PROGRAM**

WHEREAS, the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) in collaboration with the Common Pleas Court Corrections Planning Board, Adult Probations and Specialty Courts Department has identified a need for additional wrap-around services for the Mental Health & Developmental Disabilities (MHDD) Court's high-risk population with serious mental illness (SMI); and,

WHEREAS, the collaborative partners are seeking to establish a new Essential Behavioral Health Interventions and Criminogenic Needs Program; and,

WHEREAS, this new program will provide a curriculum that enhances probationary experiences for individuals with serious mental illnesses assigned to the MHDD Court; and,

WHEREAS, receiving proposals for the provision of supportive services for the MHDD Court's SMI population will allow the ADAMHS Board to assess the ability of providers to assist, develop and implement the new program; and,

WHEREAS, the ADAMHS Board Planning & Oversight Committee reviewed the ADAMHS Board staff's recommendation and recommends authorization to issue a Request for Proposal for the Cuyahoga County Corrections Planning Board's Essential Behavioral Health Interventions & Criminogenic Needs Program.

NOW, THEREFORE, BE IT RESOLVED:

1. The ADAMHS Board of Directors approves the issuance of an RFP to solicit proposals for the Cuyahoga County Corrections Planning Board's Essential Behavioral Health Interventions & Criminogenic Needs Program.
2. The ADAMHS Board CEO is hereby authorized to appoint an RFP Committee in collaboration with the Corrections Planning Board to review and evaluate the RFP proposals, and to submit for recommendation to the Board of Directors.
