
The Passing of Valeria A. Harper, MA, CDCA



Assisted Outpatient Treatment (AOT)

The ADAMHS Board of Cuyahoga County received a SAMHSA grant to develop an AOT team in collaboration with the Cuyahoga Probate Court and Frontline Services that is open to Cuyahoga residents who are under commitment at any local hospital or in the community (formally, the ADAMHS Board had a small Outpatient Commitment program that was limited to our State hospital).

The main goal of AOT is to provide assistance in helping to improve the person's quality of life and adherence to a treatment plan. The treatment plan is based on the person's needs and includes services to be provided in an outpatient setting.

This service (AOT) will be delivered by utilizing an Assertive Community Treatment (ACT) team which is an evidence-based practice. Using an ACT team will allow the treatment providers to provide comprehensive services to persons with SMI (Severe Mental Illness) who are under a civil commitment to the Cuyahoga County ADAMHS Board and are living in the Community.

This is a team effort. It not only involves the Frontline AOT team and ADAMHS Board, but requires close collaboration and team work with Cuyahoga Probate Court, CMHAs, and our local hospitals. As of December

2017, Maggie Tolbert is representing the ADAMHS Board along with Melissa Longstreth (Frontline-AOT team), and John Spiccia (Cuyahoga Probate Court) on the ACT Team. They have conducted over 11 trainings and presentations regarding AOT – the who, what, and how.

Acting CEO Scott S. Osiecki gave a presentation on the current epidemic we are facing locally and how the ADAMHS Board is providing funding and access to necessary support, treatment and recovery services. This presentation opened up a panel discussion with the audience about opioid addiction, the crisis at hand, treatment options and support available to those who living with substance use disorders and continued the conversation about how we can come together to manage the turbulence created by this crisis.

Nearly 60 people attended this event.

January 22-26: Crisis Intervention Training for Officers from Multiple Departments

Carole Ballard, MSSA, LISW, Crisis Intervention Team (CIT) Program Officer, provided CIT training to officers from seven local police departments: Lakewood, Bay Village, North Olmsted, Cleveland MetroParks, Rocky River and Westlake. CIT provides officers and other first responders with the skills they need to assist during a mental health or addiction crisis. They learn de-escalation techniques as well as best practices in crisis response. The ADAMHS Board applauds all departments that integrate CIT for their officers.

In the News...

Scott Osiecki interviewed with WCPN to discuss the passing of Ms. Harper and the Board's transition to his leadership as Acting CEO. This aired during their morning community report.

Rev. Benjamin F. Gohlstin, Sr., Board Member; Starlette Sizemore-Rice, Public Benefits Administrator; Scott Osiecki, Acting CEO, and Rev. Andrea Jacobs, MDIV, BCC, Director of Spiritual Care for OhioGuidestone were interviewed on *Missions* on Heavenly Host Internet Radio for a full hour to discuss the ADAMHS Board Faith-based Initiative. Channel 5 News reporter, Meg Shaw, interviewed Scott Osiecki about legislation (House Bill 457) that was introduced to the house in late December (*The segment has not yet been aired*). HB 457 would require anyone on parole who tested positive for heroin, fentanyl or carfentanil be immediately jailed or sent to mandatory residential treatment for 30 days at the State's expense. We know that jail is not conducive to treatment or recovery. We are also concerned that people already waiting to get into residential treatment will be bumped from their place in line and that residential treatment may not be the best choice. Good intentions aside, this legislation would put undue burden on jails and residential treatment centers with little impact on increasing recovery from substance use disorders.

Ascent Earns Large Grant from Third Frontier to Aid Addiction Recovery

Ohio Third Frontier, a commission of the State of Ohio's Development Services Agency, is committed to transforming the state's economy through the accelerated growth of diverse startup and early stage technology companies.

Ascent, an online service that connects recovering addicts to peer coaches and resources, was recently awarded \$464,000 from the Ohio Third Frontier Commission to create a new app. This is a Cleveland company that receives funding from the



ADAMHS Board. Ascent is developing an app to help those who are recovering from addiction. Peer support is essential for recovery from addiction. People living in recovery need support to get and stay clean and sober. This app will provide peer support 24-hours a day to anyone in need. This is going to give those recovering from addiction a better chance at long-term recovery.
