Breaking the Chains of Addiction Mural Unveiled

The Alcohol, Drug Addiction and Mental Health Services (ADAMHS) Board of Cuyahoga County unveiled its "Treatment Works...People Recover" mural to visually promote prevention and education about the dangers of heroin and other drugs, reduce the stigma of seeking treatment, start public discussion, and celebrate recovery through public art.



The "Treatment Works... People Recover: Breaking the Chains of Addiction" Mural was unveiled at 16021 Puritas Avenue on July 17.

This mural is the culmination of a prevention pilot program funded by the ADAMHS Board and led by Rickey Lewis of Lewis Art called "I Care About My Life and I Care About Your Life." The program was targeted to young adults ages 18-28 and had ten participants, six of whom are in treatment for heroin addiction. The project engaged core participants with individual treatment, group therapy and in mural workshops to help the individuals abstain and continue in recovery from addiction.

Scott S. Osiecki, Chief Executive Officer

of the ADAMHS Board of Cuyahoga County explained, "The idea behind this mural is to start conversations about addiction and recovery, and hopefully spur solutions to society-wide challenges, especially the current opioid crisis. Public art can evoke dialogue, inspire change and empower individuals both living in recovery and with addictions. We know that treatment works and people recover. We want the community to know that too!" The building owner, Stephanie Lorenzi, shared a message of strength and hope. She said the mural should be "A catalyst that moves people to break the chains of addiction holding them back, bring them clarity and show them that they DO have the STRENGTH to beat this disease."



Ms. Thoms faithfully served as an ADAMHS Board member since the consolidation of the two Boards in 2009. She also served as a Board member on the Cuyahoga County Community Mental Health Board for several years before the merger. She received a plaque from the ADAMHS Board in appreciation for her service and contributions to the behavioral health system.

<u>CWRU Cuyahoga County Crisis Response Services Needs Assessment Results</u>

Data from the **Cuyahoga County Crisis Response Services Needs Assessment** was presented to the Board's Joint Planning and Finance Committee on July 18, 2018. Conducted by **Case Western Reserve University's Begun Center for Violence Prevention Research and Education**, the assessment utilized both qualitative (focus groups and interviews) and quantitative (online surveys) data to gain insight about crisis services, identify barriers and impediments in meeting the needs of people in crisis, and recognize the successes of the current crisis system.

Some findings of interest included the following:

- Recognized the importance of **Crisis Intervention Trained** (CIT) officers responding to crises and recommended that all officers within Cuyahoga County receive such training.
- Crisis response is merely a bandage/revolving door for high risk/chronic utilizers, which account for a large percentage of crisis phone calls. Appropriate types and levels of care need to be established for these individuals.
- While the importance of addressing cultural and linguistic barriers was acknowledged, challenges still need to be overcome including translators with an understanding of mental health issues.
- Successful initiatives include the **Provider Emergency Services Program** (PESP), specialty courts, CIT law enforcement, and **Mobile Crisis Team** (MCT) phone responses and follow up.

The CWRU assessment places **FrontLine Services**, the Board's crisis service provider, at the forefront of crisis response. FrontLine Services representatives were present at the Board meeting and shared recent data, which included:

- MCT has been assessing individuals at high risk for suicide everyday over the past 20 years, yet it averages less than 1 person per year that dies by suicide within 30 days of its assessment.
- Very few of the more than 40,000 people assessed by the Mobile Crisis Team (2000 x 20 years) have subsequently died by suicide.

Client Rights Report Presented at Joint Planning & Finance Committee Meeting

Bill Hebble, MSW, Client Rights Officer II, gave a report depicting 2017 calendar year data collected by the **Clients Rights Division** at the July 18, Joint Planning and Finance Committee meeting. The report, which represents complaints and grievances data from the ADAMHS Board and its 44 Substance Use Disorder (SUD) and Mental Health agencies, noted that the ADAMHS Board received 1,574 calls (which included inquiries and grievances/complaints) during the period between January 1, 2017 and December 31, 2017. The majority of calls (956), came from clients, while the second-highest number (285) originated from family and friends.
