Project SOAR (Supporting Opioid Addiction Recovery) is a collaborative community response to the opioid public health crisis. The City of Lakewood, ADAMHS Board, Woodrow Project and Cleveland Clinic Lakewood Emergency Department work collaboratively to offer a peer support model in order to reduce overdoses and deaths to overdoses, provide rapid access to treatment & recovery support, and create a community based model to be replicated in other municipalities.
