**WHEREAS**, the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) Chief Executive Officer (CEO) has determined it necessary and within the administrative and operational budget to amend the contracts with the following entities:

2. Amendment to Resolution 22-04-03 Provision of Sober Living Options for Felony Offenders under the Supervision of Cuyahoga County Probation to change the start date of the contract to July 1, 2022 instead of April 15, 2022 as previously approved. All other terms of the contract remain the same. The start date will be changed in the following contracts; and,

  - b. Stella Maris
3. Amendment to Resolution 19-11-04 Returning Home Cuyahoga Housing Pilot Program and Shelter Jail Diversion Services to extend the time period until June 30, 2023 and to add new funding in the amount of \$588,861.09 for the following contracts:
  - a. EDEN, Inc - \$245,838.60
  - b. FrontLine Service - \$342,722.49; and,
4. Amendment to Resolution 22-04-03 Intensive Special Needs Child Care Services for Universal Pre-Kindergarten (UPK) to terminate the existing contractual agreement with Positive Education Program (PEP) for said program and to increase funding for the following contracts:
  - a. Achievement Centers for Children - \$21,600
  - b. Applewood Centers, Inc. - \$21,600
  - c. Beech Brook - \$21,600
  - d. Murtis Taylor Human Services System - \$21,600
  - e. OhioGuidestone - \$21,600; and,
5. Amendment to Resolution 21-11-07 Prevention Services for Serenity Health and Wellness Corp to increase funding for the prevention program in the amount of \$50,000. All prevention

services effective July 1, 2022 will be billed through GOSH. The contract end date remains unchanged for the following contract:

- a. Serenity Health and Wellness Corporation; and;

7. Amendment to Resolution 22-04-03 Mobile Response and Stabilization Services (MRSS) to extend the time period until June 30, 2023 for the following contract:

a. Bellefaire Jewish Children's Bureau; and,

B. The ADAMHS Board Chief Executive Officer is authorized to execute any necessary contractual agreements.
