**WHEREAS**, the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) has determined it necessary to enter into the following personal service contracts:

1. Attorneys/Nurses: ORC. Chapter 5122 involuntary commitment process, at hourly rates not to exceed \$85.00 for attorneys, \$150.00 for attorneys on special matters, and \$45.00 for nurses; and,
2. United Way Services First Call for Help in the amount of \$65,000.00; and,
3. Cleveland Hearing and Speech Center in the amount of \$15,000.00; and,
4. Scarborough House for ¾ House in the amount of \$15,200.00; and,
5. Union Construction Industry Partnership (UCIP) Apprenticeship Skills Achievement Program in the amount of \$150,200.00.

**WHEREAS**, the ADAMHS Board Operations and Finance has reviewed and recommends approval by the full Board of Directors of the above referenced personal service contracts.

**NOW, THEREFORE, BE IT RESOLVED:**

1. The ADAMHS Board of Directors approves the following personal service contracts:
  - a. Attorneys/Nurses: ORC. Chapter 5122 involuntary commitment process, at hourly rates not to exceed \$85.00 for attorneys, \$150.00 for attorneys on special matters, and \$45.00 for nurses; and,
  - b. United Way Services First Call for Help in the amount of \$65,000.00; and,
  - c. Cleveland Hearing and Speech Center in the amount of \$15,000.00; and,

- d. Scarborough House for  $\frac{3}{4}$  House in the amount of \$15,200.00; and,
  - e. Union Construction Industry Partnership (UCIP) Apprenticeship Skills Achievement Program in the amount of \$55,000.00.
2. The ADAMHS Board Chief Executive Officer is hereby authorized to execute the contracts and make expenditures pursuant to the above referenced personal services contract, subject to the availability of funding.
