Notice of Funding Award (NOFA) - Cuyahoga County Corrections Planning Board Pass-Thru allocation funds from the Community Correction Act and the Cuyahoga County Common Pleas Court for Residential Substance Abuse Treatment

WHEREAS, pass-thru funding has been made available to the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (ADAMHS Board) from the Community Correction Act in the amount of \$80,000 and Cuyahoga County Common Pleas Court in the amount of \$513,465 for a total amount of \$593,465 for Residential Substance Abuse Treatment services provided by:

- Catholic Charities Services
- ORCA House
- Fresh Start

WHEREAS, in CY2010, the ADAMHS Board entered a similar agreement with the County to allocate \$593,465 to Catholic Charities Services, ORCA House and Fresh Start for substance abuse treatment services in a residential setting to individuals involved with the Cuyahoga County Common Pleas Court; and,

WHEREAS, this collaboration between the Courts and treatment providers is intended to provide a comprehensive team approach to address substance abuse and behaviors associated with illicit activity which leads to incarceration; and,

WHEREAS, the ADAMHS Board is satisfied with the services provided by Catholic Charities, ORCA and Fresh Start and desires to continue the treatment programs for the providers; and,

WHEREAS, the ADAMHS Board staff recommends that the Board of Directors accept the funding and authorize the ADAMHS Board to enter into any necessary interagency agreements and/or amended interagency agreements.

NOW, THEREFORE, BE IT RESOLVED:

- 1. The ADAMHS Board of Directors approves and accepts:
 - (a) Notice of Funding Award (NOFA) from the Cuyahoga County Corrections Planning Board Pass-Thru allocation funds from the Community Correction Act in the amount of \$80,000 and the Cuyahoga County Common Pleas Court in the amount of \$513,465 for a total amount of \$593,465 for Residential Substance Abuse Treatment services provided by:
