APPROVAL OF SFY 2012-2013 COMMUNITY PLAN

WHEREAS, the Ohio Department of Mental Health (ODMH) and Ohio Department of Alcohol and Drug Addiction Services (ODADAS) has designed an integrated community planning process for State Fiscal Year (SFY) 2012-2013; and,

WHEREAS, the Alcohol, Drug Addiction and Mental Health Services (ADAMHS) Board of Cuyahoga County is required by Ohio law to prepare and submit to both the Ohio Department of Mental Health (ODMH) and the Ohio Department of Alcohol and Drug Addiction Services (ODADAS), a plan for the provision of prevention, alcohol and other drug and mental health services in its catchment area and constitutes that the ADAMHS Board's application for state funds is prepared in accordance with procedures and guidelines established by ODADAS and ODMH; and,

WHEREAS, ORC section 340.03 establishes Boards as the prevention, alcohol and other drug and mental health planning agency for the county under its jurisdiction. Each Board must:

- Evaluate the need for recovery support services, prevention, alcohol and other drug and mental health treatment services
- Assess the gaps in behavioral health programs/services
- Set program/service priorities in relation to availability of funding

WHEREAS, the Community Plan for SFY 2012-2013 emphasizes the key role of Boards in planning to meet the needs of their residents to the extent financially feasible. Attention is also paid to the Legislative intent in creating County Boards as a citizen-directed funding, planning and evaluating organization; and,

WHEREAS, the Community Plan Guidelines for SFY 2012-2013 are designed to give all boards the opportunity to highlight unique areas of achievement, identify service priorities and to illustrate strategies to sustain the behavioral healthcare system in the wake of funding reductions; and,

WHEREAS, the Community Plan is due to ODMH and ODADAS by September 1, 2011; and,

WHEREAS, the Planning and Oversight Committee recommends that the full Board of Directors approve the SFY 2012-2013 Community Plan.
